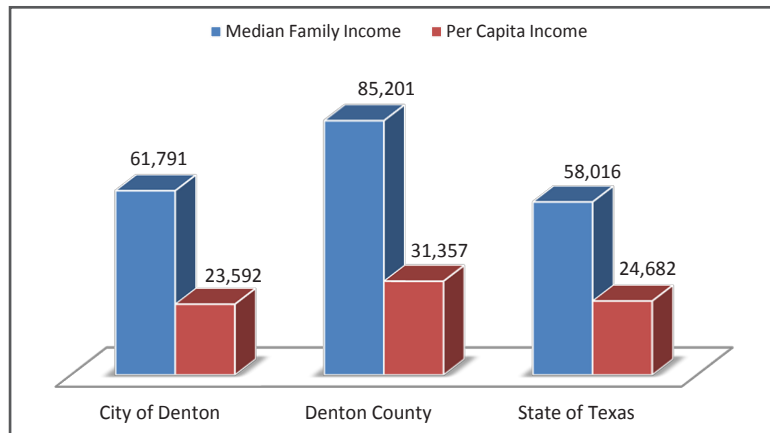

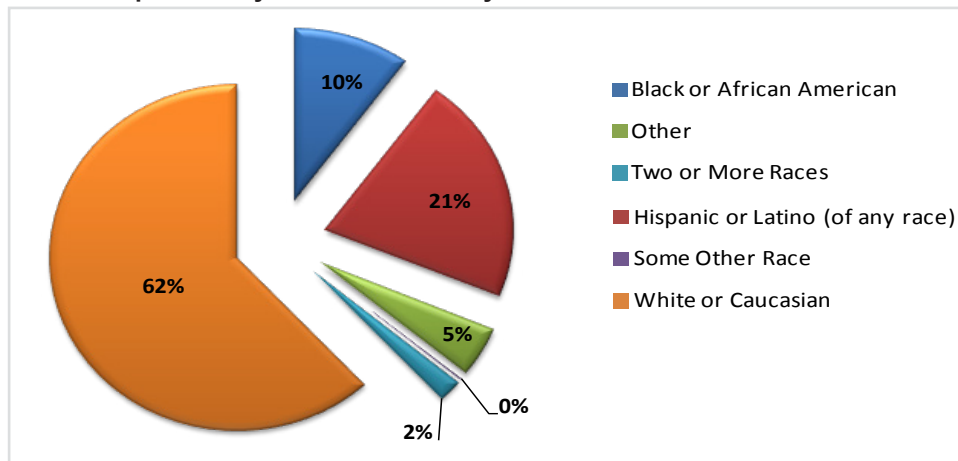

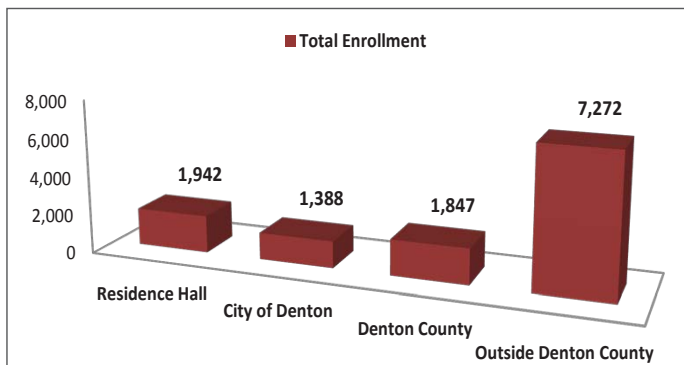
Denton Population by Race and Ethnicity

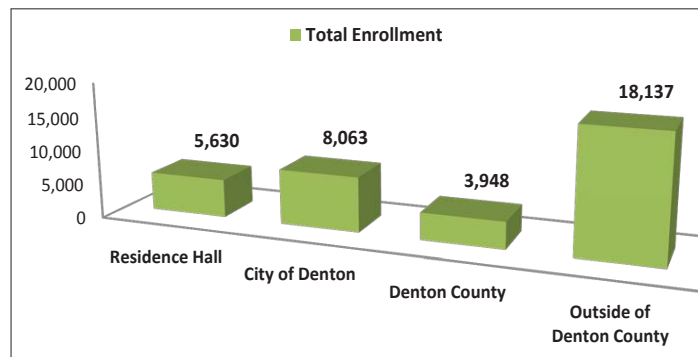

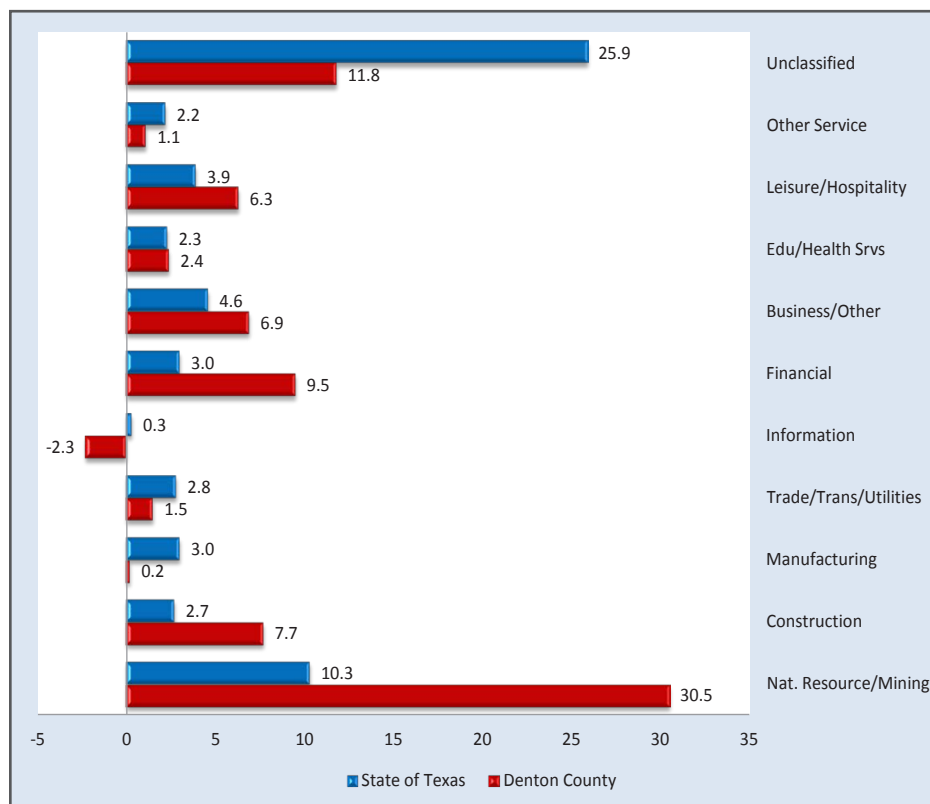

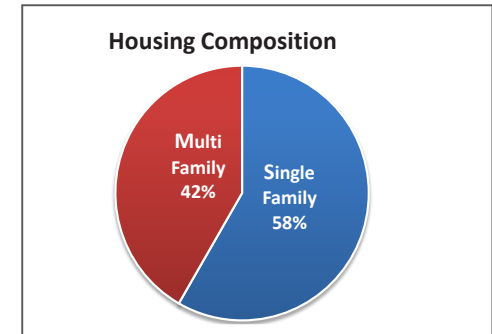

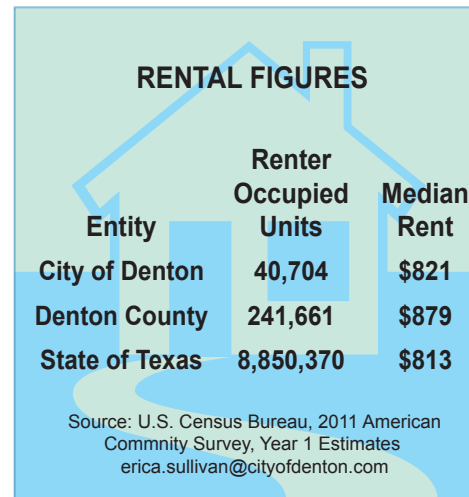

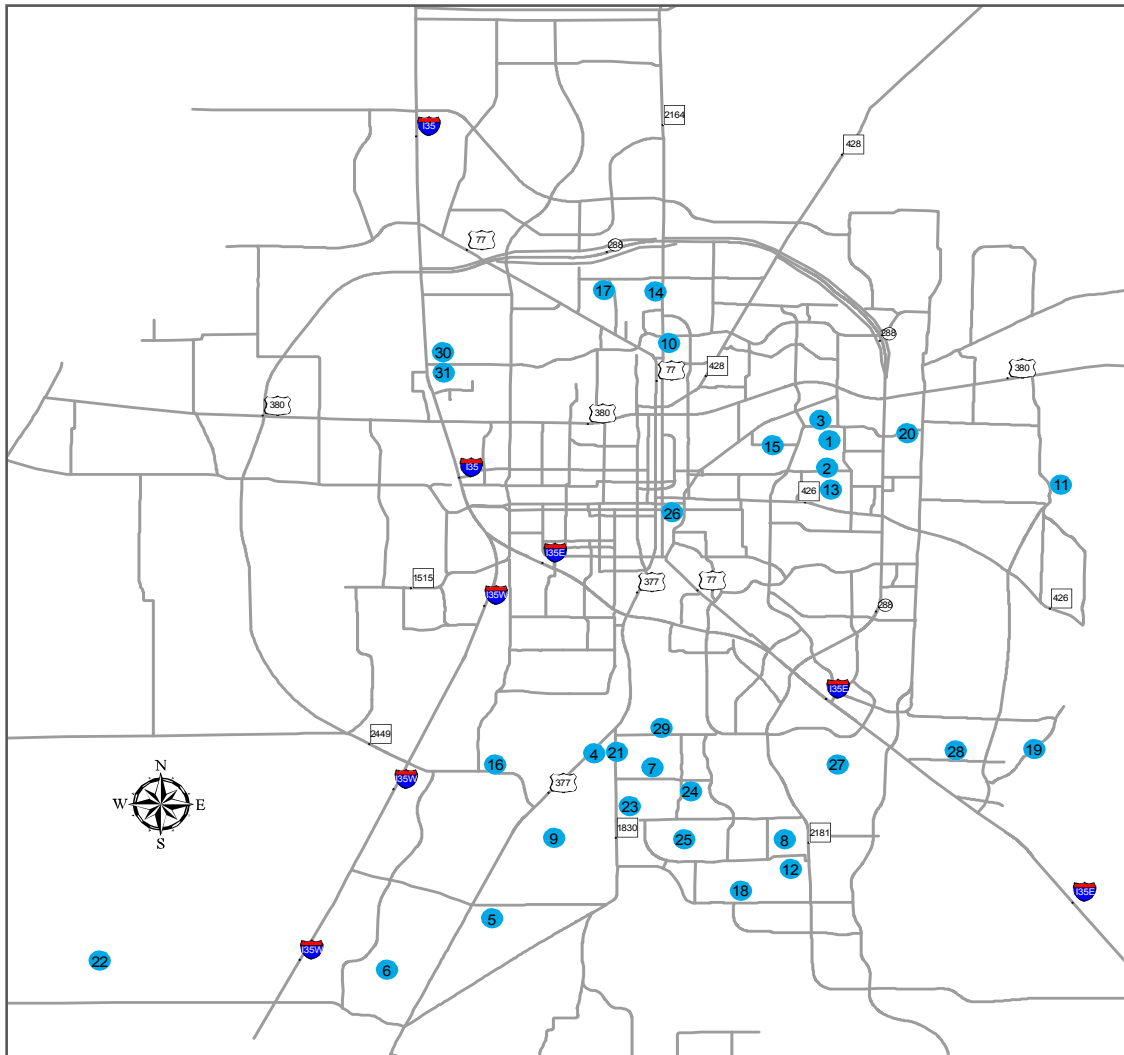

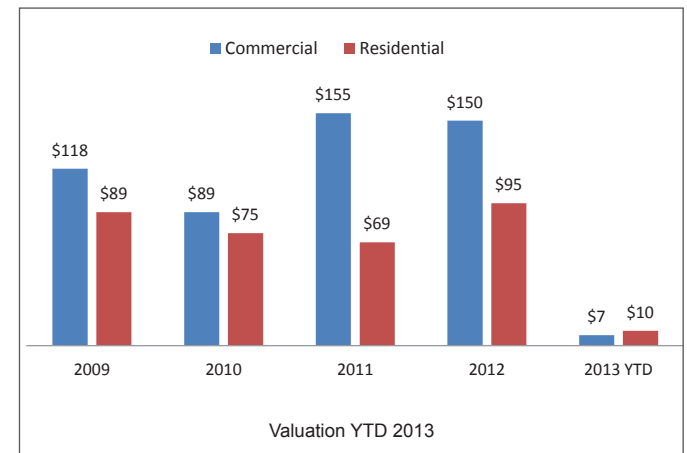

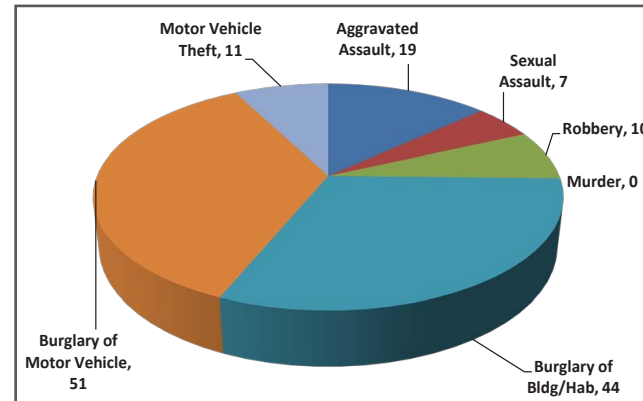
